He explained that factors such as charity and uncompensated care write-offs, bad debt write-offs, lack of payments from the USMS, losses sustained by the CCHD Pharmacy, and the costs of EMS support have placed a significant financial burden on the organization.

4.) Public Comment on Proposed Concho County Hospital District Tax Rate

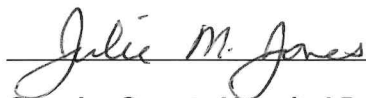
